**Note:** This form applies to properties that are currently addressed by a house name which requires amending and / or properties which are to have their main access changed from their existing address to another road name. This can be due to a new road being created changing your existing access or if a property is on a corner of two roads and the main entrance / driveway has been relocated.

Properties that are solely changing their name must only apply if the name is the main property identifier instead of a street number. (e.g. Rose Cottage, High Street, Shanklin or 1 Rose Cottages, High Street, Shanklin).

Properties that are currently using a name as well as a street number (deemed an 'alias') may inform Island Roads Ltd via email and we will notify various bodies, but the number **must** be used / clearly displayed at all times (e.g. Dove House, 1 Main Road). It is the number that the emergency services, etc. will use to locate your property. As an alias does not form part of the official address, we do NOT require a fee.

You will receive a letter confirming that the change has been made approximately 10 days after this form and payment is received by us. At which time you may alter any signage that identifies your property. It is advisable to display a notice for a short period of time, i.e. 3-6 months, informing persons of the previous property name to aid delivery of post still marked with the old address.

Whilst Island Roads shall notify **Land Registry** of changes in property names / addresses, it should be noted that property titles will not be amended as a result of this notification. The property owner will need to make a specific application to Land Registry for the change to the title and pay the appropriate fee.
